## 2. **Entry Period:**

## 3. **The Prize Draw - Croatia Jet Set Escape:** One Winner and up to three Guests will receive a curated Croatia luxury travel experience.

- The Prize includes:
    - helicopter or chauffeur transfers between the Winner's UK home location and a London private airport;
    - return private jet travel for the Winner and Guests between London and Croatia;
    - VIP transfers from the arrival airport to the yacht embarkation location;
    - a seven-night all-inclusive fully crewed luxury yacht experience cruising the Adriatic;
    - £10,000 spending money.
  - a. Transfer by helicopter or chauffeur between the Winner's UK home location and the departure airport and on return at the end of the Prize experience. Subject to operational requirements, availability, weather conditions and the Winner's location, the Winner may choose between the transfer options made available by the Promoter.
  - b. Private jet travel for the Winner and Guests between London and Croatia, together with VIP transfers between the arrival airport and the yacht embarkation location. Departure airport, routing, flight scheduling, aircraft type and operational travel arrangements shall be determined by the Promoter or relevant Third-Party Suppliers acting reasonably.
  - c. Subject to availability and operational requirements, a seven-night all-inclusive fully crewed luxury yacht experience in Croatia. "All-inclusive" refers solely to the inclusions expressly stated by the Promoter and does not include personal purchases, discretionary spending, optional excursions, medical costs, visas, passports or any item not expressly included within the Prize description.
  - d. Travel arrangements, including flights, transfers, yacht itinerary, marina locations, onboard arrangements, activities and operational scheduling, may change due to weather conditions, safety requirements, supplier decisions or other circumstances outside the Promoter's reasonable control.
  - e. As part of the Prize, the Winner will receive £10,000 spending money to support and enhance the overall Prize experience. The spending money will be provided in two stages, with the timing, payment method, administration and release determined by the Promoter acting reasonably, as follows:

4. **Redemption Window and Travel Dates:** Subject to availability and operational requirements, the Winner may redeem the main Croatia holiday experience during:

- August to September 2026; or
- June to September 2027

Exact travel dates shall be agreed between the Winner and the Promoter.

5. **Additional VIP Taster Weekend:** Where the Winner chooses to schedule the main Croatia holiday experience during the 2027 redemption window, the Winner will also receive an additional VIP taster weekend (“Taster Weekend”) intended to allow the Winner and up to three Guests to begin enjoying the Prize experience ahead of the main holiday. - a. - b. Subject to availability, operational requirements and any applicable blackout dates determined by the Promoter or relevant Third-Party Suppliers, the Taster Weekend is intended to take place during Summer 2026 on dates agreed between the Winner and the Promoter.
- c. The timing, itinerary, accommodation, activities, guest participation arrangements and operational details relating to the Taster Weekend shall be determined by the Promoter acting reasonably.
- d. The Taster Weekend may include photography, filming, publicity or promotional activities connected with the Prize Draw and Ventus promotional campaigns. Any such activities shall be conducted in accordance with Clause 17 (Publicity) of the General Terms.
- e. Where the Winner is unavailable, unwilling or unable to participate in the Taster Weekend, the main Croatia holiday experience shall remain unaffected and the Promoter shall have no obligation to provide an alternative Taster Weekend, substitute experience or cash alternative.
- f. The Promoter reserves the right to amend, postpone or substitute the Taster Weekend where reasonably necessary due to operational, supplier, scheduling, safety, publicity or other circumstances outside the Promoter’s reasonable control.

6. **Guests:** The Prize is for the Winner and up to three Guests. Guests must be at least 18 years of age or be accompanied by a parent or legal guardian who accepts responsibility for them. All Guests are subject to the applicable provisions of these Prize Draw Terms and the General Terms.

7. **Publicity and Winner and Guest Content:** The Winner and Guests may be invited to participate in photography, filming, publicity and promotional activity relating to the Prize Draw and Prize. Participation in publicity activity shall remain subject to Clause 17 (Publicity) of the General Terms.

    - iii) access to certain coastal locations, restaurants, beaches, facilities or excursion points may require travel across jetties, docks, stone pathways, gradients or steps located near or above the sea.
  - b. Due to the nature of the Prize, including private jet travel, tender transfers, marina boarding arrangements, moving marine environments and coastal access routes, certain elements of the experience may not be suitable for individuals who rely on wheelchairs, mobility scooters or substantial mobility assistance equipment.
  - c. Participants with accessibility, mobility or medical requirements who are uncertain whether the Prize may be suitable for them are encouraged to contact the Promoter before entering the Prize Draw for further information regarding the nature of the experience.

  - f. Where the Promoter acting reasonably determines that a particular element of the Prize cannot be safely or reasonably adapted to accommodate a Winner or Guest, the Promoter may, at its reasonable discretion and in accordance with the General Terms, amend the affected element of the Prize or provide an Alternative Prize.

  - v. the Promoter and Third-Party Suppliers reserve the right to remove or refuse participation in any element of the Prize where a Winner or Guest behaves in a manner that is unsafe, unlawful, abusive, disruptive or otherwise inappropriate;

- vi. certain elements of the Prize experience may involve photography, filming or promotional activity in accordance with Clause 17 (Publicity) of the General Terms; and
- vii. references to private jets, yachts or luxury accommodation describe the nature of the Prize experience only and no ownership interest, leasehold interest or ongoing usage rights are granted to the Winner or Guests.

Nothing in these Terms and Conditions limits or excludes any rights you have as a consumer under applicable law, including the Consumer Rights Act 2015. Any dispute or claim; including those that are not contractual in nature, arising from or in connection with these Terms shall be brought before the courts of England and Wales. Consumers based in other parts of Great Britain will, however, continue to benefit from any mandatory rights under their local laws and may choose to pursue proceedings either in the English courts or in the courts of their own jurisdiction.
